## The challenge of continuity

The IT infrastructure of your business is a critical resource now as indispensable as financial or human resources.

The occurrence, which you're never safe from, of a massive disruption of your information systems will certainly generate losses of means of production, or worse, loss of data with nightmarish consequences: failure to respond to requests of your customers, delays in orders, delivery times not respected, termination of contracts, loss of confidence or even liabilities, disappointed and angry shareholders, and loss of reputation often impossible to restore.

This kind of event does not happen only to others. In circles of specialists, we often say: "There are two types of organizations: those who have suffered a major disaster and those who will."

The statistics from the Business Continuity Institute report that, out of 100 organizations that were hit by a disaster, 45 will not recover and 30 will disappear within the next 2 years. Let us be realistic: a business continuity plan will not eliminate the risk of disaster for your company, but you will have made every possible effort to reduce the probability of occurrence and impact on your business.

And even if you are aware that you need to protect your organization against the myriad of threats to your business from the crash of the "wrong" server to the fire not to mention the massive loss of telecommunications or half of your staff missing due to a flu pandemic - you are probably not able to provide the necessary resources to take care about this issue or may not know how to deal with a problem of such complexity.

### **BCM** Lifecycle

Business continuity management lifecycle, as shown in the figure below, has, in his heart, the foundations of the continuity policy and program management. This is followed by four key steps that focus on the implementation and maintenance: understanding the organization, determining business continuity management strategy, developing and implementing a business continuity management response, and finally exercising, maintaining and reviewing. The last crucial step to make it all feasible, is the need for embedding the business continuity management in the organization's culture



#### **BCM Policy and Programme Management**

The BCM Policy is the key document that sets out the scope and governance of the BCM programme, and reflects the reasons why BCM is being implemented. It provides the context in which the required capabilities will be implemented, and identifies the principles to which the organization aspires and against which its performance can be audited.

#### Understanding the organization

This is the professional practice within the BCM Lifecycle that reviews an organization in terms of what its objectives are, how it works functionally and the constraints of the environment in which it operates. The information collected makes it possible to determine how best to prepare an organization to be able to manage disruptions which might otherwise seriously or fatally damage it.

Determining Business Continuity Strategy

This is the professional practice within the BCM Lifecycle that determines which BCM strategies will meet the BCM Policy and organizational requirements and selects tactical responses from available options.

#### Developing and implementing a BCM response

"Developing and Implementing a BCM Response" is the professional practice within the BCM Lifecycle that implements agreed strategies through the process of developing a set of Business Continuity Plans.

The aim of the various plan (s) covered in this stage is to identify, as far as possible, the actions and the resources which are needed to enable the organization to manage an interruption whatever its cause, back to a position where normal business processes can resume.

#### Exercising, maintaining and reviewing

Most organizations exist in a dynamic environment and are subject to changes in people, processes, market, risk, environment, and geography and business strategy. To ensure that their BCM capability continues to reflect the nature, scale and complexity of the organization it supports, it must be current, accurate, complete, exercised and understood by all stakeholders and participants.

#### Embedding BCM in the organization's culture

The successful establishment of BCM within the organization's culture is dependent upon its integration with the organization's strategic and day-to-day management as well as its alignment with business priorities.
